PROGRAM FROM MEETING OF 7/13/2022:

Rotary Nature Preserve - Connie Taillion and Mark Burch

Connie Taillion, the environmental specialist for the City of White Bear and Mark Burch, former city engineer, gave an excellent program concerning the Rotary Nature Preserve. The land was acquired in the 1980s by the City and our Rotary Club made substantial financial contributions and "hands on" improvements to the area. At Phase 1, the Rotary Club members built an on-site bathroom. Phase 2 involved building the log picnic shelter, and Phase 3 was building and installing a boardwalk across the wetland. Mark Burch was the project manager of all 3 Phases. The future is bright with Connie Taillion being in charge of making restoration changes. The goal is to incorporate native plants into the Preserve and control or eliminate invasive species as well as nonnative plants. Native plants are those which were indigenous to the area between 1847-1907. The poor Amur Maple, although popular, is not a native and will be removed. The restoration project will be accomplished in phases thru 2023 including the installation of a prairie and pollinator garden and the restoration of the woodland and wetland buffers. Thank you, Mark Burch and Connie Taillion, for this excellent program and all you do for the Rotary Nature Preserve.
