Patty is a life-long resident of WBL and FAMILY is the most important thing to her. Her parents, she and her siblings (Mike Fleming and Katie Stender), her three kids (Steve, Katie, and Dave), and most of her grandkids have all graduated from White Bear Lake schools and have stayed connected to the community. "Go Bears!" The Christmas holiday is an important time for the family – everyone (31-35 people) gathers – and costumes play a big role in the festivities!

Patty travelled to Kenya early in 2020 with a group of Rotarians and among other projects visited the Bridges school, founded by a Mahtomedi couple. She was fortunate to be on the last flight out of Nairobi on March 16 before COVID closed things down, while the Bridges were stuck there until almost the end of July. Patty founded H2O for Life in 2017 to engage youth in the U.S. to learn about the water crisis and to take action through service learning and to provide funding for water and sanitation projects around the world. She was engaged in Rotary projects before joining our local club and for a number of years has been involved in a collaborative project for water, sanitation and hygiene education for 30 schools in Nigeria. This project received three Global grants and was commissioned in April 2021, with recognition of WBL Rotary. Every school had a Rotary connection and is a good example of how to combine Rotary resources with great non-governmental organizations (NGOs). In total, \$1.2 million has supported water projects in 60 schools around the world.

**Program: Kevin Donovan** introduced David Schultz who was invited to speak on the pros and cons of the proposed Constitutional amendment for education, first discussed with us by Justice Page in February. Prof. Schultz is a Hamline University Professor of Political Science and a professor in the Hamline and University of Minnesota Schools of Law. He is the author of 30 books and 100+ articles on various aspects of American politics, election law, and the media and politics.

Prof. Schultz began by stating that does not support the Page amendment and believes it is the wrong solution to a serious problem we need to address. He believes we share a common interest and objective in improving the educational achievement of all of our students in Minnesota and addressing the racial achievement gap. However, he argues that:

1. Passing the amendment is a simplistic solution to address the bigger problem. There are many dimensions to education disparities and we need to be thinking about all aspects of students' lives: their families, their communities, their schools.
2. This amendment takes away protected rights that are already in the Constitution and replaces it with untested legal language, which is unique (not found in any other state). A well-established body of law affirming education as a fundamental right exists today and there is a significant risk of guessing future court interpretations.
3. The amendment fails to understand the factors that really affect learning and teaching.
4. The amendment is basically a diversion of political resources that could be better used in adopting policies that we already know could do something. The political will to take action is lacking.
5. There are some very troubling things regarding how the amendment talks about standardized tests and about what commitment it provides for publicly funded education in Minnesota. But standardized tests are biased and if the uniformity clause in the MN Constitution which guarantees the right to public education is taken away, the state could walk away.

Prof. Schultz's perspective is shaped by his experience as an educator, teaching for 40 years, studying the role of the courts, law and social change, teaching constitutional law and working with a community action agency and the Institute on Race and Poverty. He referenced a January 14, 2020, MN Post article that detailed how Minnesota is one of the most racially segregated states in the U.S., in relation to the wealth gap, incarceration, health care, and learning disparities. He believes we have delayed too long in addressing these disparities but that the Page Amendment is the wrong approach. In sum, he believes there is a race problem in Minnesota in terms of education disparities, but that there is little evidence that the Constitutional language proposed in this amendment will solve anything. He believes it is up to the political will of the legislature to adopt measures that could reduce disparities, improve teaching, and focus on things we need to do if we're serious about addressing educational disparities.
